PEMBROKESHIRE COUNTY COUNCIL

The County of Pembroke (Various Roads, Letterston) (Prohibition of Waiting) Order, 1968

Notice is hereby given that on the 12th August 1968, the Pembrokeshire County Council made an Order under sections 1 and 2 of the Road Traffic Regulation Act 1967, the effect of which will be that from 26th August 1968, no vehicles shall be permitted to wait in the following lengths of roads in the Parish of Letterston:

1. *Village Road.* From its junction with the Trunk Road (A.40) in a westerly direction for a distance of 37 yards.
2. *Station Road.* From its junction with the Trunk Road (A.40) in an easterly direction for a distance of 55 yards.

There will be exceptions for persons boarding or alighting from vehicles for the loading and unloading of goods, for vehicles which are being used in connection with building operations and similar works and to enable vehicles to take in petrol, oil, water or air from any garage situated on or adjacent to the lengths of road.
