*The County Borough of Bolton (Restricted Road) (No.) Order, 196 .**The County Borough of Bolton (40 m.p.h. Speed Limit) (No.) Order, 196 .*

Notice is hereby given that the Council of the County Borough of Bolton intend to apply to the Minister of Transport for consent to the making of Orders as follows:—

- (a) under sections 72 and 73 of the Road Traffic Regulation Act 1967 the effect of which will be to impose a speed limit of 30 m.p.h. on that length of Chorley Old Road, from a point 539 feet from the centre line of Romney Road for a distance of 180 feet in a westerly direction; and
- (b) under section 74 of the Road Traffic Regulation Act 1967, the effect of which will be to impose a 40 m.p.h. speed limit on that length of Chorley Old Road from a point 719 feet from the centre line of Romney Road to the east side of Old Kiln Lane.
