HIGHWAYS ACT, 1959

The London—Thurso Trunk Road (Thirston New-houses—Felton Bank Top Side Roads) Order 1968

The Minister of Transport hereby gives notice that, in relation to the above-mentioned Trunk Road at Felton in the County of Northumberland, he has made under section 9 of the above Act an Order, the effect of which is:

- (a) to authorise the Minister:
 - (i) to improve, raise, lower or otherwise alter a highway, and
 - (ii) to construct a new highway at Felton aforesaid, and
- (b) to provide for the transfer of the said new highway to the County Council of Northumberland as from the date on which the Minister notifies the Council that the new highway has been completed and is open for through traffic.
