The section empowers the above-named Council to grant upon terms and conditions which they think fit licences for pleasure boats and pleasure vessels let for hire or used for carrying passengers for hire and also to boatmen or persons assisting in the navigation of such boats or vessels. The section prohibits any person from letting for hire any boat or vessel which is not so licensed. Forms of application for licence are obtainable from the undersigned.

Powers and Duties of Local Authorities

The Pleasure Boats (No. 6) Order, 1968 *Made 31st July 1968*

1. In pursuance of the powers conferred upon me by section 3 of the Public Health Acts Amendment Act 1907(a) and Article 3 of the Transfer of Functions (Secretary of State and Minister of Health) Order, 1946(b), I, by this Order on an application made to me by the council of the urban district named in the Schedule to this Order, declare section 94 of that Act (which confers power to license pleasure boats) to be in force in the urban district named in the Schedule to his Order.

2. In pursuance of the said powers, I direct that the said council shall within six weeks from the date of this Order cause a copy thereof and so much of the Schedule thereto as relates to their district to be published in two or more local newspapers circulating in the District.

3. This Order may be cited as the Pleasure Boats (No. 6) Order 1968.
