

HYDE BOROUGH COUNCIL

The Borough of Hyde (Oldham Street) (Prohibition of Waiting) Order, 1968

Notice is hereby given that the Hyde Borough Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1967, the effect of which will be to provide that no person shall cause or permit the waiting of a vehicle in Oldham Street (a) on its south-westerly side, from its junction with Corporation Street to its junction with Onward Street; (b) on its north-easterly side from its junction with Corporation Street to a point 30 feet from that junction; (c) on its north-easterly side from a point 135 feet from its junction with Corporation Street to the south-east boundary of the ambulance station between the hours of 8 a.m. and 6 p.m. on Mondays, Wednesdays and Fridays and (d) on its north-easterly side from a point 30 feet from its junction with Corporation Street for a distance of 105 feet in a south-easterly direction between the hours of 8 a.m. and 6 p.m. for a longer period than two hours, or if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting of the vehicle on that length of road.

The Order will include exemptions to permit persons to board or alight from a vehicle, to enable goods to be loaded or unloaded, to enable a vehicle to be used in connection with any funeral, any building operation or demolition, the removal of any obstruction to traffic, or the maintenance of the road or services therein.

A copy of the proposed Order and map relating thereto may be inspected at the Town Hall, Hyde, during normal office hours.

The Borough of Hyde (Milk Street) (Prohibition and Restriction of Waiting) Order, 1968

Notice is hereby given that the Hyde Borough Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1967, the effect of which will be to revoke The Borough of Hyde (Milk Street) (Prohibition of Waiting) Order, 1965 and to provide that no person shall cause or permit the waiting of a vehicle in Milk Street (a) on its north-westerly side for its entire length and (b) on its south-easterly side for its entire length during the hours of 8 a.m. and 6 p.m. for a longer period than two hours, or if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting of the vehicle on that side of road.

The Order will include exemptions to permit persons to board or alight from a vehicle, to enable goods to be loaded or unloaded, to enable a vehicle

to be used in connection with any funeral, any building operation or demolition, the removal of any obstruction to traffic, or the maintenance of the road or services therein.

Notice is hereby given that on the 23rd September 1968, the Hyde Borough Council made an Order under sections 1 and 2 of the Road Traffic Regulation Act 1967, the effect of which is to provide that as from the 4th October 1968, no person shall cause or permit the waiting of a vehicle in Corporation Street on its north-westerly side (a) from its junction with Jackson Street to a point 45 feet south-west of that junction, and (b) from its junction with Jackson Street to a point 30 feet north-east of that junction.
