Notice is hereby given that the County Council of Durham intend to apply to the Magistrates of the Darlington County Petty Sessional Division sitting at the Magistrates' Court, Parkgate, Darlington, on Monday, the 28th day of October 1968, at 10.30 a.m. for an Order under section 108 of the Highways Act, 1959, authorising the closure of part of Footpath No. 16 at Sedgefield in the Parish of Sedgefield in the Sedgefield Rural District.

The said Footpath No. 16 commences at the junction with Footpath No. 14 near Spring Lane and extends to Stockton Road (Road A.177).

The part proposed to be closed—230 yards or thereabouts in length—extends from the junction with Footpath No. 14, near the north-west corner of the School Playing Field, and extends southwards then eastwards along the boundary of the said playing field to the junction with Footpath No. 15 at the south-east corner of the said playing field.

An alternative route exists along Footpath No. 14, eastwards then along Footpath No. 15 southwards to rejoin the part of Footpath No. 16 which is to remain open.

Part of Road C.38—North of Petty's Nook*

Notice is hereby given that the County Council of Durham intend to apply to the Magistrates of the Darlington County Petty Sessional Division sitting at the Magistrates' Court, Parkgate, Darlington, on Monday, the 28th day of October 1968, at 10.30 a.m. for an Order under section 108 of the Highways Act 1959, authorising the closure of part of Road C.38, north of Petty's Nook in the Parish of Little Stainton in the Darlington Rural District.

The said Road C.38 commences at Fighting Cocks and extends through Sadberge and Great Stainton to its termination at Sedgefield.

HAILSHAM RURAL DISTRICT COUNCIL

*Hailsham Rural District (Herstmonceux Right of Way
No. 54A) Public Path Diversion Order, 1968*

Notice is hereby given that on the 16th day of September 1968, the Minister of Housing and Local Government confirmed the above Order.

Its effect is to divert public right of way No. 54A at Flowers Green Farm in the Parish of Herstmonceux which at present runs from its junction with road 696 (Lime Cross to Herstmonceux Church) opposite Penlands Farm (at the point marked A on the map) for a distance of approximately 760 feet to its junction with public rights of way Nos. 32 and 54B (marked B on the map) in the south-east corner of the field through which it runs so that the line of the public right of way will run from a point opposite the property known as Little Butlers (approximately 420 feet south of the present commencement at A on the map) in an easterly direction along the southern boundary of the same field for approximately 760 feet to join rights of ways Nos. 32 and 54B as before (at the aforementioned point marked B on the map). The old public right of way will be closed from the 11th November 1968.

A copy of the confirmed Order and the map contained in it has been deposited at the Council Offices, Cortlandt, Hailsham, and may be inspected free of charge during the usual office hours.

The Order becomes operative as from the 27th September 1968, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
