Provided that

(a) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition tht no pant of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

(b) In the said Churchyard, in any grave space in which no interment has heretofore taken place, burial may be allowed, subject to the condition that no part of the coffin containing the body shall be at a depath less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be citted as the Burial Grounds (Churchyard of St. Mary the Virgin, Willand, Devonshire) Order 1968.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 7th day of December next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such Representation one month before the said 7th day of December.
