#### TENDERS FOR TREASURY BILLS

(being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are

- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

To add The National Giro Service of the Post Office to the list of parts of undertakings in respect of which refunds of selective employ-ment tax may not be made.

The Trunk Road (High Street, Glyn-Neath) (Prohibition of Waiting) Order 1968
