## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### *Rubber Proofed Garment Making Industry Wages Council*

The Rubber Proofed Garment Making Industry Wages Council hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Rubber Proofed Garment) (No. 2) Order 1967 (Order R.P.G.(25)); (2) amending the provisions relating to customary holidays set out in the Wages Regulation (Rubber Proofed Garment) (Holidays) Order 1967 (Order R.P.G.(23)); and (3) the revocation of Order R.P.G.(25).

Particulars of the proposals are contained in the Wages Council's Notice R.P.G.(26) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 8th November 1968. Any such representation should bear the writer's address and signature and be sent to the Secretary, Rubber Proofed Garment Making Industry Wages Council, 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections, and quote the number of the Wages Council's Notice of proposals R.P.G.(26).

### ROAD TRAFFIC REGULATION ACT Section 6

#### *Great Cambridge Road (A.10)—Closure of Pedestrian Gap in the Central Reservation*

The Minister of Transport hereby gives notice that he proposes to make an Order the effect of which will be to prohibit permanently pedestrians and vehicles from proceeding through the opening in the fence on the central reservation of Great Cambridge Road (A.10) opposite Nos. 29 and 30 Carlton Terrace.

Persons affected by the Order will be able to cross Great Cambridge Road either by using the subway 200 yards to the north or the pedestrian crossing at the Cambridge Roundabout to the south.
