#### *France: Official Certificate*

The Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on him by the Imported Food Regulations, 1968, he hereby varies the recognition of the Official Certificates reproduced in the Schedules to the notices published in the *London Gazette*s dated 29th March 1938, 11th February 1964, and 10th September 1968, for the importation of meat and meat products from France, to the extent shown in the Schedule hereto.
