Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payments in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be deted

Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England. 9. HIGHWAYS ACT 1959

The Newport—Worcester Trunk Road (Usk—Coldra Diversion) Order 1968

The Secretary of State hereby gives notice that he has made an Order under section 7 and 44 of the above Act providing:

- (a) that a highway which he proposes to construct between Usk and Newport (Coldra) in the County of Monmouth shall become a trunk road as from the date when the Order comes into operation, and
- (b) that the length of the Newport-Worcester Trunk Road to be superseded shall cease to be a trunk road as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Monmouth (who will become the highway authority respon-sible for that length) that the new road is open for through traffic.

Copies of the Order, the title of which is "The Newport—Worcester Trunk Road (Usk—Coldra Diversion) Order 1968 (S.I. No. 1991) can be pur-chased, price 6d., either through any bookseller, or direct from any branch of Her Majesty's Stationery Office.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959 or on

the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may within six weeks from 3rd January 1969, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
