PRICES AND INCOMES ACT 1966

REPORT BY THE NATIONAL BOARD FOR PRICES AND INCOMES

Gas Prices (Final Report)

On 3rd October 1967, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs and the Minister of Power referred to the National Board for Prices and Incomes the question of the increases in gas tariffs and coke prices sought by the gas industry to the National Board for Prices and Incomes for examination against the background of the Government's policies for nationalised industries, including the financial target for the relevant period. The Board has now made its final report and in accordance with section 5 (1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Power hereby give notice that the report was first published as Command Paper Number 3924 on 13th February 1969.
