WAITING AND LOADING RESTRICTIONS

City of Westminster and London Borough of Brent

Notice is hereby given that the Greater London Council are about to consider a proposal that they should make an Order under section 6 of the Road Traffic Regulation Act 1967, the effect of which would be, in the City of Westminster and the London Borough of Brent:

1. to impose restrictions (a) on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Fridays inclusive and (b) on waiting by vehicles for the purpose of loading or unloading goods between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive in:

Brondesbury Park between the north-western kerblines of Winchester Avenue and Chevening Road and a point 150 feet north-west of the north-western kerb-line of The Avenue, Willesden.

Brondesbury Road between the north-eastern kerb-line of Salusbury Road and a point opposite the party wall of Nos. 127 and 129 Brondesbury Road.

Canterbury Road between its junctions with Salusbury Road and Kilburn Lane and its junction with Carlton Vale.

Carlton Vale between its junction with Canterbury Road and a point opposite the party wall of Nos. 215 and 217 Carlton Vale.

Harvist Road between the south-western kerb-line of Salusbury Road and a point 25 feet north-east of a point opposite the party wall of Nos. 2 and 4 Harvist Road.

Kilburn Lane between its junctions with Salusbury Road and Canterbury Road and a point opposite the party wall of Nos. 329 and 331 Kilburn Lane.

Malvern Road between its junctions with Carlton Vale and Canterbury Road and a point opposite the south-easternmost flank wall of Nos. 1-16 Kilburn House, Malvern Place.
