### ROAD TRAFFIC REGULATION ACT, 1967

#### *Imposition of 40 m.p.h. Speed Limit*

Notice is hereby given that the Minister of Transport intends to make an Order under the Road Traffic Regulation Act, 1967, prohibiting the driving of motor vehicles at a speed exceeding 40 m.p.h. on the length of road specified in the Schedule to this notice.

Any objection to the making of the Order should be sent to the Divisional Road Engineer, Ministry of Transport, Welbar House, Gallogate, Newcastle-upon-Tyne 1, not later than the 11th April 1969, quoting the reference number DN 128/2/T73/02.

#### SCHEDULE

Levens Bridge—Broughton-in-Furness—Workington—Aspatria—Carlisle Trunk Road (A.595) from 163 yards south-west of the entrance to Suttle House south-westwards for 200 yards.

#### *The Trunk Road (Cheadle) (Box-Junctions) Order 1969*

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act, 1967, the effect of which will be that no person shall drive a vehicle into the boxed areas at the junction of Gatley Road and High Street, Cheadle, or at the junction of High Street and Stockport Road, Cheadle, and thereafter drive it in such a direction that it becomes necessary, owing to the presence of stationary vehicles for any part of the vehicle to remain at rest within that area.

Objections to the Order must be sent to the Secretary, Ministry of Transport, St. Christopher House, Southwark Street, London S.E.1, by 11th April, 1969, quoting the reference TTPA 5/59/04 and stating the reasons for objection.

#### *The Trunk Road (Various Roads, Henley-on-Thames) (Prohibition and Restriction of Waiting) Order, 1969.*

The Minister of Transport proposes to make an Order under sections 1 and 3 of the Road Traffic Regulation Act, 1967, the effect of which will be to re-enact the existing restrictions relating to the waiting of vehicles on the A.423 Trunk Road at Henley-on-Thames and extend them so that waiting will also be prohibited on both sides of Northfield End from 58 yards north-west of its junction with Badgemore Lane to 194 yards north-west of that junction.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein. The Order will also exempt disabled drivers from the time limits where limited waiting is permitted.
