CIVIC AMENITIES ACTS

NOTTINGHAMSHIRE COUNTY COUNCIL

Conservation area at Mansfield

Notice is hereby given that the Nottinghamshire County Council as Local Planning Authority after consultation with the Borough of Mansfield have designated the area referred to in the Schedule of this Notice as a conservation area for the purposes of Section I of the Civic Amenities Act 1967. The designation area, which the County Council consider to be an area of special architectural or historic interest, the character or appearance of which should be preserved or enhanced, will be the subject of stringent control of development and the County Council intend to take such action as may be available to them to secure the preservation and general improvement of the area.

The conservation area is more particularly defined on the map which may be inspected free of cost during normal office hours at the office of the County Director of Planning, County Hall, West Bridgford, Nottingham, or at the office of the Town Clerk, Carr Bank, Mansfield.

THE SCHEDULE

In the Borough of Mansfield

The boundary includes the site of the Bridge Street Methodist Church, crosses Bridge Street and follows

the eastern perimeter of the warehouse building opposite, adjacent to the River Maun. The boundary then follows the southern edge of this warehouse and continues down the western bank of the river to a point lining through with the southern boundary of St. Peter's School main building. The designation line follows the perimeter of the school to the south-west and back up to the north to a point where it is met by the line of the back of the footpath projected across the north side of Midworth Street. Numbers 1 and 3 Midworth Street are included within the area. The boundary follows the re-alignment of these two properties and carries on to include Church House and numbers 10, 12, 14 and 16 Church Side. From here the designation crosses Church Side, follows the north-west perimeter of the Church yard and crosses Bridge Street to include the Trustee Savings Bank and numbers 4a, 4b, 5 and 7 Bridge Street. A separate but associated area comprises 32, 34 and 36 Church Street.
