

- (b) *Bridge Street*. On both sides from a point 67 yards south of the junction of Bridge Street and Mounts Road to the junction of Bridge Street and Holyhead Road.
- (c) *Lower High Street*. On both sides from a point 117 yards north of the junction of Bridge Street and Mounts Road to the junction of Bridge Street, Lower High Street and Holyhead Road.
- (d) *Mounts Road*. On both sides from a point 34 yards east of the junction of Bridge Street and Mounts Road to the junction of Bridge Street and Mounts Road.
- (e) *Perry Street*. On both sides from a point 34 yards west of the junction of Holyhead Road and Perry Street to the junction of Holyhead Road and Perry Street.
2. (a) *Holloway Bank*. On the west side from a point 40 yards north of the junction of Holloway Bank and Bilport Lane to the junction of Holloway Bank and Hill Top.

- (c) *Dudley Street*. On both sides from a point 34 yards south of the junction of Dudley Street and Carters Green Passage to the junction of Dudley Street and Carters Green.
- (d) *Guns Lane*. On both sides from a point 34 yards west of the junction of Carters Green and Guns Lane to the junction of Carters Green and Guns Lane.
- (e) *John Street*. On both sides from a point 100 yards east of the junction of High Street and John Street to the junction of High Street and John Street.

- (b) *New Pitt Street*. On the west side for the whole length from the junction of New Pitt Street and New Street to the junction of New Pitt Street and Bull Street.
- (c) *New Pitt Street*. On the east side from a point 50 yards south-east of the junction of New Pitt Street and New Street to the junction of New Pitt Street and New Street.
- (d) *New Pitt Street*. On the east side from a point 50 yards north-west of the junction of New Pitt Street and Walsall Street to the junction of New Pitt Street and Walsall Street.
- (e) *Bull Street*. On both sides from a point 67 yards north-east of the junction of High Street and Bull Street to the junction of Bull Street, Overend Street.

- (b) *Old Meeting Street*. On both sides from a point 90 yards south of the junction of Old Meeting Street and Bilhay Lane to the junction of Old Meeting Street and Black Lake.
- (c) *Swan Lane*. On both sides from a point 34 yards west of the junction of Black Lane and Swan Lane to the junction of Black Lane and Swan Lane.
- (d) *Bilhay Lane*. On both sides from a point 34 yards west of the junction of Old Meeting Street and Bilhay Lane to the junction of Old Meeting Street and Bilhay Lane.

4. (a) *Birmingham Road*. On both sides of Birmingham Road from the junction of Birmingham Road and High Street to a point 67 yards west of the junction of Birmingham Road and Roebuck Street.
- (b) *Birmingham Road*. On both sides from a point 275 yards west of the junction of Birmingham Road and Colliery Road to the Borough Boundary.
- (c) *Halfords Lane*. On both sides from a point 45 yards south of the junction of Birmingham Road and Halfords Lane to the junction of Birmingham Road and Halfords Lane.
