**NOTICE OF APPLICATION FOR LICENCE TO  
ABSTRACT WATER AND TO VARY EXISTING  
LICENCE**

Notice is hereby given that an application is being made to the Kent River Authority by A. Coleman Limited, the Old Parsonage, Goudhurst, Kent, to vary the licence Serial No. 9/40/3/112/SR to abstract water from the River Test in the parish of Goudhurst in the county of Kent at points TQ7085,3740 and TQ7110,3800. The variation applied for is to amend the daily rate from 173,000 gallons to 400,000 gallons, the hourly rate from 10,800 gallons to 71,000 gallons, during the period 1st March—21st May only. The original rates apply during the period 21st May—31st August as before. There will be no increase in the total annual authorised abstraction. Application is also being made to the Authority for a licence to abstract 10,000,000 gallons per annum at the above location at the rate of 800,000 gallons per day and 71,000 gallons per hour during the period 1st November—30th April for the same purpose. It should be noted that most of this water will be used for frost protection irrigation and will return to the stream within hours of the abstraction.

**THE GAS ACT, 1948**

*The Gas (Declaration of Calorific Value) Regulations, 1949, and*

*The Gas (Declaration of Calorific Value) (Amendment) Regulations, 1951*

**ROAD TRAFFIC ACTS**

**ALDERSHOT BOROUGH COUNCIL**

*The Borough of Aldershot (High Street/Brighton Road) (Prohibition of Waiting) Order 1969*

Notice is hereby given that the Aldershot Borough Council propose to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1967 the effect of which will be to prohibit the waiting of vehicles (including loading and unloading) at all times on that part of the north side of Brighton Road from its junction with High Street to a point fifteen yards in a south-westerly direction and on the south-west side of Brighton Road from its junction with High Street to a point fifteen yards in a south-westerly direction.
