WAGES COUNCILS ACT 1959

Button Manufacturing Wages Council (Great Britain)

The Button Manufacturing Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) varying the provisions relating to statutory minimum remuneration set out in the Wages Regulation (Button Manufacturing) Order 1968 (Order V.
