ROAD TRAFFIC REGULATION ACT, 1967

*The Trunk Road (Various Roads, Beeston)
(Restriction of Waiting) Order, 1969*

The Minister of Transport has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, the effect of which is that no person shall cause or permit any vehicle to wait between the hours of 8 a.m. and 8 p.m. in that length of the north-east of Birmingham—Nottingham Trunk Road (A.453), known in part as Queens Road and in part as Queens Road East in the Urban District of Beeston and Stapleford in the County of Nottingham, which extends from a point 47 yards south-east of the junction of Queens Road with King Street in a northerly direction to the boundary of the said Urban District with the City of Nottingham
