Notice is hereby given that the Greater London Council give notice that they are about to make an Order under section 9 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be, in the London Borough of Hammersmith:

(1) to revoke the prohibition on vehicular traffic from entering or leaving that length of Hammersmith Bridge Road which lies between the south-eastern kerbline of Hammersmith Bridge Road and its

kerbline of Hammersmith Bridge Road and its junction with Worlidge Street;

(2) to prohibit vehicular traffic from entering that length of Worlidge Street which lies between a point 57 feet south-east of the south-eastern kerbline of Hammersmith Bridge Road and a point 62 feet south-east of that kerbline;

(3) to prohibit vehicular traffic from turning right

(3) to prohibit vehicular traffic from turning right from Hammersmith Bridge Road into Worlidge

Street:

(4) to require all vehicular traffic to turn left from Worlidge Street into Hammersmith Bridge Road;

(5) subject to paragraph (2) above, to allow two way traffic working for vehicular traffic in way traffic wo Worlidge Street.

The Order will come into operation not earlier than 27th June 1969.

PRESCRIBED ROUTES AND WAITING AND LOADING RESTRICTIONS

London Borough of Haringey

Notice is hereby given that the Greater London Council are about to consider a proposal that they should make Orders under sections 6 and 84p of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of

which would be, in the London Borough of Haringey:

- 1. In connection with a proposed road improvement, to impose a system of traffic control in the vicinity of the junction of Philip Lane, Spur Road and West Green Road which could involve one-way working in a clockwise direction around West Green Common.
- 2. To prohibit the right turn from West Green Road into Clinton Road.
- 3. To amend the hours during which the existing restrictions on waiting by vehicles apply from between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on Mondays to Saturdays inclusive to between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive
  - High Road, Tottenham between a point opposite the southern wall of Nos. 17 to 32 Rheola Close and the southern kerb-line of Lordship Lane.
- 4. To amend the hours during which the existing restrictions on waiting by vehicles including waiting for the purposeof loading and unloading goods apply from between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive to between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in Black Boy Lane, Clinton Road and within the length of West. Green Road which lies between a point opposite the party wall of Nos. 5 and 6 Vicarage Parade and the west side of its junction with Philip Lane.
- 5. To impose restrictions on waiting by vehicles between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:
  - High Road, Tottenham between the northern kerb-line of Lansdowne Road and the southern kerb-line of Hampden Lane.
  - Lansdowne Road between its junction with High Road, Tottenham and a point opposite the party wall of Nos. 3 and 3A Lansdowne Road.
  - Lordship Lane between its junction with High Road, Tottenham and a point opposite the western kerb-line of Elsden Road.
  - Philip Lane between the west side of its junction with West Green Road and a point 20 feet south-west of a point opposite the party wall of Nos. 261 and 263 Philip Lane.

Spur Road

West Green Road between the west side of its junction with Philip Lane and a point opposite the party wall of Nos. 245 and 247 West Green Road.

The carriageways immediately surrounding and in the vicinity of West Green Common.

The restrictions referred to in paragraph 5 would also apply to the first 60 feet of Cornwall Road, Tottenham.

- 6. To impose restrictions on waiting by vehicles for the purpose of loading and unloading goods between 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:
  - igh Road, Tottenham between the northern kerb-line of Lansdowne Road and the southern kerb-line of Hampden Lane.
  - Lansdowne Road between its junction with High Road, Tottenham and a point opposite the eastern wall of Nos. 636-638 High Road, Tottenham.
  - Lordship Lane between its junction with High Road, Tottenham and a point 36 feet east of the eastern wall of Millicent Fawcett Court, Pembury Road.

In respect of paragraphs 5 and 6, exemptions would be provided in the Order to permit vehicles to wait in order to pick up and set down passengers, to carry out essential services or when used by local authorities in pursuance of statutory powers or duties,

authornes in pursuance of statutory powers of duties, and, except as provided in paragraph 6, to load and unload goods for limited periods.
