ROAD TRAFFIC REGULATION ACT 1967

Imposition of 30 m.p.h. Speed Limit—Swimbridge Newland, Devon

Notice is hereby given that the Minister of Transport intends to make an Order, under section 72(3) and section 73(1) of the Road Traffic Regulation Act 1967, the effect of which will be that the length of road specified in the Schedule to this notice shall become subject to a speed limit of 30 m.p.h.

That length of the Taunton-Fraddon Trunk road (A.361) at Swimbridge Newland in the County of Devon which extends from a point 465 yards south-east of the centre of Newland Bridge, in a south-easterly direction for a distance of 33 yards.

The Trunk Road (Egham Hill, Egham) (Prohibition of Entry and Exit) Order, 1969

The Minister of Transport has made an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, the effect of which is that no person shall cause any vehicle to enter or leave that length of the London-Penzance Trunk Road (A.30), known as Egham Hill in the Urban District of Egham in the County of Surrey, at its junction with Malt Hill in the said Urban District.
