And whereas, in pursuance of her powers under the said section 5(4), the First Secretary of State and Secretary of State for Employment and Productivity, by a direction published in the Gazette on 25th February 1969, extended the said period of three months by three months and by a direction published in the Gazette on 22nd May 1969, further extended the said period of three months by two months;

4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said section 5(4), hereby directs that the said period of three months be further extended by one month.

# DRAFT SPECIAL REGULATIONS

Factories Act 1961

In pursuance of section 180 of, and Schedule 4 to the Factories Act 1961, the Secretary of State for Employment and Productivity hereby gives notice that she proposes to make special regulations imposing requirements as to the provision, replacement and storage of boots (or clogs in the case of a person willing to have them) and gaiters to protect from and storage of boots (or clogs in the case of a person willing to have them) and gaiters to protect from molten metal and material at such a temperature that its contact with the body would cause a burn to the feet and ankles of persons employed in certain operations in foundries. They also provide that such persons shall wear the boots, clogs and gaiters provided and take care of them.
