WEST RIDING OF YORKSHIRE COUNTY COUNCIL

The County Council of the West Riding of Yorkshire (Mapplewell Cross Roads, Mapplewell) (Restriction of Waiting) Order, 1969.

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday in any of the lengths of road specified in the Schedule to this notice, except for so long as may be necessary to enable a person to board or alight from or cause goods to be loaded on to or unloaded from a vehicle, or to enable a vehicle to be used for certain building operations, road works, works of Statutory Undertakers, or in pursuance of Statutory Powers or duties.

Lengths of road at Mapplewell in the Darton Urban District.

- Greenside Road (B.6428).* From its junction with the Darton-Staincross Station (Class II) County Road (B.6131) to its junction with Braithwaite Street.

The County Council of the West Riding of Yorkshire (King's Road, Wombwell) (Restriction of Waiting) Order, 1969.

Notice is hereby given that the County Council of the West Riding of Yorkshire propose to make an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be to prohibit the waiting by vehicles on the following lengths of road at Wombwell, in the Wombwell Urban District:

1. Between 8 a.m. and 6 p.m. on any day other than a Sunday on that length of King's Road from the junction with Church Street to the junction with Kelvin Grove and Collindridge Road.
2. Between 8 a.m. and 6 p.m. Mondays to Fridays inclusive, on the western side of King's Road from the junction with Collindridge Road to the junction with Mellor Road.

Exemptions will be provided in the Order to permit waiting for so long as may be necessary to enable a person to board or alight from or cause goods to be loaded on to or unloaded from a vehicle, or to enable a vehicle to be used for certain building operations, road works, works of Statutory Undertakers, or in pursuance of Statutory Powers or duties.
