## **ROAD TRAFFIC REGULATION ACT 1967**

The Trunk Road (Park Road and Preston Road, Chorley) (Restriction of Waiting) Order 1969

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit any person from causing or permitting any vehicle to wait between 8 a.m. and 8 p.m. in that length of the London-Carlisle-Glasgow-Inverness Trunk Road (A.6), known in part as Park Road and in part as Preston Road in the Borough of Chorley, which extends from a point opposite the northern boundary wall of Astley Park to its junction with Hazel Grove.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition,

nection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

The Trunk Road (Cheadle) (Box-Junctions) Order 1969

## The Trunk Road (London Road, Lexden) (Prohibition of Waiting) Order 1969

The Trunk Road (Skipton Road, Steeton-with-East-burn) (Prohibition of Waiting) Order 1969

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit the waiting of vehicles in that length of the North West of Doncaster-Wakefield-Bradford-Skipton-Kendal Trunk Road (A.629), in the Parish of Steeton-with-Eastburn in the County of York, West Riding, which extends from the western side of its junction with Chapel Road to the eastern side of its junction with Grange Road Grange Road.
