The effect of the Order is to put parts of the ancient monument known as Durrington Walls in the Parish of Durring-ton in the County of Wiltshire (in respect of which an Interim Preservation Notice under section 10 of the said Act is in force) under the more lasting protection of the Minister, and to make provision for compensation to persons affected.

2. The Durrington Walls Wiltshire (Parts) Pre-servation Order 1969 is not subject to special parliamentary procedure.
