Notice of Application to Stop Up a Highway

Notice is hereby given that the Royton Urban District Council being the highway authority for the highway hereinafter mentioned intend to apply to the Magistrates' Court sitting at Royton on Wednesday, the 10th day of December 1969, at the hour of 10 in the forenoon, for an Order under section 108 of the Highways Act 1959, authorising the highway known as "passage at the rear of Nos. 1, 2 and 3 Haggate Crescent and of Nos. 11, 11A, 15 and 17 Cecil Street, Royton" for a distance of 30 yards from its junction with Cecil Street to its junction with Haggate Crescent, and for a distance of 39 yards co-extensive with the rear boundaries of Nos. 11, 11A, 15 and 17 Cecil Street, to be stopped up on the grounds that it is unnecessary.

The effect of the proposed Order is shown on the plan deposited at the Town Hall, Royton, where it may be inspected free of charge between the hours of 9 a.m. and 12.30 p.m. and 2 p.m. and 5 p.m. on weekdays (excluding Saturday).

Settle Rural District, Parish of Austwick. Closing of a section of the Austwick-Lawkland-Giggleswick Station (Class III) County Road (C.243) at Austwick.

Notice is hereby given that the County Council of the West Riding of Yorkshire acting as highway authority intend to apply to a Magistrates' Court sitting at The Court House, Ingleton, at 10.30 a.m., on Friday, the 2nd day of January 1970, for an Order under section 108 of the Highways Act 1959, authorising the stopping up of a length of approximately 160 yards of the public road known as the Austwick-Lawkland-Giggleswick Station (Class III) County Road (C.243) from a point approximately 667 yards north of its junction with the North West of Doncaster-Kendal Trunk Road (TR.65) to a point approximately 827 yards north of that junction at Austwick in the Rural District of Settle, in the West Riding of the County of York, on the ground that it is unnecessary.

The Pleasure Boats Order, 1969
Made 24th October 1969.*

Notice is hereby given that this Order may be cited at the Pleasure Boats Order, 1969.

In pursuance of the powers conferred upon me by section 3 of the Public Health Acts Amendment Act, 1907 and Article 3 of the Transfer of Functions (Secretary of State and Ministry of Health) Order, 1946, I, by this Order on an application made to me by the Council of the Rural District named in the Schedule to this Order, declare section 94 of that Act (which confers power to license pleasure boats) to be in force in the Rural District named in the Schedule to this Order.

In pursuance of the said powers, I direct that the said Council shall within six weeks from the date of this Order cause a copy thereof and of the Schedule thereto to be published in two or more local newspapers circulating in the District.
