- 1. to impose one-way traffic working in:
  - (a) Burney Street-from north-east to south-
  - (b) Greenwich High Road, between the north-eastern kerb-line of Royal Hill and the south-western kerb-line of Stockwell Street—from south-west to north-east.
  - (c) Royal Hill, between the north-western kerb-line of Burney Street and its junction with Greenwich High Road—from south-east to north-west.
  - (d) Stockwell Street-from north-west to southeast.
- to prohibit the right turn from Greenwich High Road into Stockwell Street;
- 3. to impose restrictions on waiting by vehicles at any time of the day or night throughout the week in:
  - (a) Burney Street.
  - (b) Royal Hill between the north-western kerb-line of Burney Street and a point 60 feet south-east of the south-eastern kerb-line of Greenwich High Road.
  - (c) Stockwell Street between a point 60 feet south-east of the south-eastern kerb-line of Greenwich High Road and the north-western kerb-lines of Burney Street and Nevada Street.

Exemptions from the restrictions referred to in paragraph 3 above have been provided to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods for limited periods, to carry out essential services or when used by local authorities in pursuance of statutory powers or duties.

The alternative route will be by way of Stockwell Street, Burney Street and Royal Hill.
