

TOWN AND COUNTRY PLANNING  
ACTS 1962 AND 1968*Walthamstow*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of Nicholson Road, Cross Street, and a length of Essex Grove, Walthamstow, E.17, to enable development consisting of the erection of old people's flatlets, including warden's accommodation, flats and maisonettes to be carried out by the Waltham Forest L.B.C. under Part III of the said Act.

The proposed Order will require the provision of a new highway.

TOWN AND COUNTRY PLANNING  
ACTS 1962 AND 1968*West Bromwich*

The Minister of Transport hereby gives notice that he has made an Order under section 153 of the Town and Country Planning Act 1962, entitled "The Stopping Up of Highways (County Borough of West Bromwich) (No. 3) Order 1969", authorising the stopping up of Piercy Street and lengths of St. Luke's Road, Oxford Street, Paul Street and Moor Street, West Bromwich, and requiring the provision of new roads.

NATIONAL PARKS AND ACCESS TO THE  
COUNTRYSIDE ACT, 1949*Parish of Dufton—County of Westmorland*

ROSTHERNE MERE*Parish of Rostherne—County of Cheshire*

LINDISFARNE*Parish of Holy Island—County of Northumberland*
