NOTICE OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT, 1968
SECTION 94

County Council of the Administrative County of the North Riding of Yorkshire Public Path Stopping Up and Diversion Order (Pickering) No. 2, 1969.

Notice is hereby given that the above named Order (hereinafter referred to as "the Order") made on the 5th day of November 1969, is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the County Council of the Administrative County of the North Riding of Yorkshire as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish a footpath situate within the Urban District of Pickering and within the Administrative County of the North Riding of Yorkshire, namely, the public footpath running from a public highway known as Whitby Road, at a point in the south east corner of Field No. 1133 on the O.S. map, Sheet No. 91-7 (1928 Edition), northwards along the eastern boundary of this field, to a point at its north-eastern corner, and create an alternative public footpath in lieu.

A copy of the Order and the map contained in it has been deposited at the Pickering Urban District Council Offices, and may be inspected free of charge at the Council Offices, Memorial Hall, Pickering, between 9 a.m. and 5 p.m. on Mondays to Fridays in any week.

Any representation or objection with respect to the Order may be sent in writing to the Clerk of the North Riding of Yorkshire County Council, County Hall, Northallerton, not later than 19th January 1970, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the County Council of the Administrative County of the North Riding of Yorkshire may, instead of submitting the Order to the Minister of Housing and Local Government for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Minister for confirmation, any representations and objections which have been duly made and not withdrawn will be sent to the Minister with the Order.

Notice of Publication of Definitive Map and Statement

Municipal Boroughs of Buxton and Glossop and Urban District of Ashbourne, Belper, Matlock and Wirksworth.

The Derbyshire County Council, in exercise of their duty under Part IV of the above Act hereby give notice that, no applications to Quarter Sessions as to the provisional maps and statements for the above-mentioned districts having been received, they have prepared a definitive map under section 32 of the Act showing public footpaths, bridleways and roads used as public paths in respect of those parts of the county comprised in the Municipal Boroughs of Buxton and Glossop and the Urban Districts of Ashbourne, Belper, Matlock and Wirksworth, together with the statements containing particulars thereof.

The definitive maps are a reproduction of the provisional maps as no applications have been made to the Quarter Sessions.

In accordance with the provisions of the First Schedule, Part III, paragraph 9 of the above Act, if any person desires to question the validity of the definitive map on the ground that the map is not within the powers of the Act or on the ground that any requirement of the Act or of any regulation made thereunder has not been complied with in relation to the preparation of the map, or of any draft or provisional map on which the map is based, he may, within 6 weeks after the date of publication of this notice make an application to the High Court.

NOTE. *Alterations since relevant date.* It is emphasised that the definitive map shows the position as at the "relevant date" namely 1st June 1954, for the Municipal Boroughs of Buxton and Glossop, 1st September 1953 for the Urban District of Ashbourne and 1st June 1953 for the Urban District of Belper, Matlock and Wirksworth. Subsequent creations, closures and diversions of public paths in pursuance of statutory powers are not shown.
