SECTION 95*The Bootle (Brook Road) Extinguishment of Footpaths Order, No. 1, 1970*

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 7th day of January 1970, is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the Bootle County Borough Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to extinguish the public right of way running at the rear of the premises 60 Irlam Road from its commencement at its junction with Brook Road, and extending southwards and thence eastwards at the rear of the site of the demolished cottage Number 2 Brook Road for a total distance of 42½ lineal yards or thereabouts.

A copy of the Order and the map contained in it has been deposited at the Office of the Town Clerk and Chief Executive Officer, Town Hall, Bootle, and may be inspected there free of charge between the hours of 9 a.m. and 5.30 p.m. on weekdays.

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 7th day of January 1970, is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the Bootle County Borough Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to extinguish the public right of way extending from its junction with Bedford Place in a northerly direction for its full length along the rear of the sites of properties Numbered 64 to 78 (even numbers only inclusive) St. Johns Road, for a distance of 125 lineal yards or thereabouts.
