## HIGHWAYS ACT 1959

*The Swansea—Manchester Trunk Road and the Shrewsbury—Dolgellau Trunk Road (Welshpool By-Pass) Order, 197 .*

and

*The Swansea—Manchester Trunk Road and the Shrewsbury—Dolgellau Trunk Road (Welshpool By-Pass Side Roads) Order, 197 .*

The Secretary of State hereby gives notice that he proposes to make the following Orders:

1. an Order under sections 7 and 44 of the above Act providing—

(a) that the roads which he proposes to construct at Welshpool in the County of Montgomery shall become trunk roads as from the date when the Order comes into operation, and

(b) that the lengths of the Swansea—Manchester and the Shrewsbury—Dolgellau Trunk Roads to be superseded shall cease to be trunk roads as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Montgomery (who will become the highway authority responsible for those lengths) that the new trunk roads are open for through traffic; and

2. an Order under section 9 of the above Act authorising the Secretary of State

(a) to improve, raise, lower or otherwise alter highways,

(b) to stop up highways,

(c) to construct new highways,

all at Welshpool aforesaid, and providing for the transfer of each of the said new highways to the highway authority specified therefore in the Order as from the date on which the Secretary of State notifies that authority that the new highway has been completed and is open for through traffic.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours from 6th February 1970, to 6th May 1970, at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, at the offices of Montgomeryshire County Council, County Offices, Welshpool and Welshpool Borough Council, High Street, Welshpool.

Any person may not later than 6th May 1970, object to the making of the Orders, by notice to the Secretary of State at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, CF2 1YU, quoting the reference RD 75/1/231/08 and stating the grounds of objection.
