

(b) that the length of the London-Fishguard Trunk Road to be superseded shall cease to be a trunk road as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Pembrokeshire (who will become the highway authority responsible for that length) that the new trunk road is opened for through traffic; and

2. An Order under section 9 of the above Act authorising the Secretary of State

- (a) to carry out improvements to the Pembroke-Canaston Bridge Road;
- (b) to stop up highways;
- (c) to construct a new highway to connect the Pembroke-Canaston Bridge Road with the above-mentioned Trunk Road, all at Canaston Bridge aforesaid, and providing for the transfer of the said highway to the County Council of Pembrokeshire as from the date on which the Secretary of State notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the draft Orders and of the relevant plans may be inspected free of charge at all reasonable hours from 20th February 1970 to 20th May 1970 at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, at the offices of Pembrokeshire County Council, County Offices, Haverfordwest, Narbeth Rural District Council, Council Offices, Narbeth.

Y SWYDDFA GYMREIG HIGHWAYS ACT 1959

The Raglan-Llandoverly Trunk Road (Llywel Diversion Side Roads) Order 1970

The Secretary of State hereby gives notice that in relation to the above mentioned Trunk Road at Llywel in the County of Brecon he has made under section 9 of the above Act an Order which will authorise the Secretary of State:

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop up highways,
- (c) to construct a new highway to connect the new trunk road with the above mentioned Trunk Road, all near Llywel aforesaid, and to

provide for the transfer of the said highway to the County Council of Breconshire as from the date on which the Secretary of State notifies the Council that the new highway has been completed and is open for through traffic.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks from 20th February 1970 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
