and formed into one Consolidated Chapelry for the said church of Saint Matthew under the style of 'The Consolidated Chapelry of Saint Matthew, Millbrook, Jersey';

"And with the like consent of the said Bishop of the said diocese (testified as aforesaid) we further represent that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Matthew, situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof;

"And with the consents (testified as aforesaid) of the said Lieutenant-Governor and Commander-in-Chief of the Island of Jersey, acting on behalf of Your Majesty, of the said Bishop of the said diocese and of the said Francis Albert Turner, as incumbent for the time being of the benefice of Saint Lawrence, Jersey, being the patron of the said church of Saint Matthew, we further represent that upon the day when any Order of Your Majesty in Council ratifying this Representation is published in the London Gazette, and without any conveyance or assurance in the law other than such Order, the right of presentation to the said church of Saint Matthew shall be surrendered in favour of Your Majesty, and the patronage of the Consolidated Chapelry shall belong wholly to Your Majesty, Your Heirs and Successors.

## "THE SCHEDULE

"All those contiguous portions (coloured pink on the map annexed hereto) of the parishes of Saint Lawrence, Saint Peter and Saint Andrew in the Island of Jersey and in the diocese of Winchester which are together bounded on the south in part by the sea and on the remainder of the south as well as on the south-west, west, north-west, north, north-east, east and south-east by an imaginary line commencing at and south-east by an imaginary line commencing at the western boundary of the said parish of Saint Peter at a point upon the shore of Saint Aubin's Bay where it meets the boundary of the parish of Saint Brelade which point is at approximately 27 yards to the west of the west side of the slip leading on to the beach and following the said boundary between the parish of Saint Peter and the parish of Saint Brelade extending in a north-westerly direction along the said boundary for a distance of approximately 422 yards and thereby crossing the main Saint Helier the said boundary for a distance of approximately 422 yards and thereby crossing the main Saint Helier to Saint Aubin's road known as the Route de la Haule and thence following the western side of the public road known as La Ruelle ès Ruaux to the point of its junction with the public road known as Mont des Vignes and from this latter point extending in the said by the said the Mont des Vignes and from this latter point extending in a north-easterly direction along the middle of the said road Mont des Vignes for a distance of approximately 247 yards and then in an easterly direction for a distance of approximately 120 yards and then in a north-easterly direction for a distance of approximately 60 yards to its junction with the main road known as New Beaumont Hill and from this point continuing along the middle of the main road known as Old Beaumont Hill first in a north-westerly direction for a distance of approximately westerly direction for a distance of approximately 100 yards and then in a north-easterly and easterly direction for a distance of approximately 207 yards to a point opposite to a boundary stone inscribed 'St. M. 1969 No. 1' and placed on the east side of the said road near to the more northerly of the two gate pillars at the extrance to the property 'Hillside', and extending thence eastwards to such boundary stone and continuing thence in a straight line in a northeasterly direction for a distance of approximately 292 yards to a boundary stone inscribed 'St. M. 1969 No. 2' and placed on the west side of the public road known as Les Grupieaux alongside the more road known as Les Grupieaux alongside the more northerly of the two gate pillars at the entrance to the property 'Haverford West' and from this point extending to the middle of the said public road and then continuing along the middle of the said road first in a northerly, then in a north-easterly and finally in a northerly direction for a distance of approximately 228 yards to a point opposite to a boundary stone inscribed 'St. M. 1969 No. 3' and placed on the north side of the said road near to the wall forming part of the property 'High Tor' and from this point extending to the said boundary

stone and from the said stone continuing in a northasterly direction for a distance of approximately 146 yards to a boundary stone inscribed 'St. M. 1969 No. 4' and placed on the west side of the main road leading along Saint Peter's Valley at 49 feet 3 inches to the north-west of the south-west corner of the house known as 'Homestill' and from this point extending to the middle of the soil west corner of the house known as 'Homestill' and from this point extending to the middle of the said main road and then continuing along the middle of the said main road in a south-easterly then an easterly and finally in a northerly direction along the middle of the main road known as Meadow Bank for a distance of approximately 98 yards to a point opposite to a boundary stone inscribed 'St. M. 1969 No. 5' and placed on the west side of the said main road known as Meadow Bank at 12 feet 6 inches to the north of the north-eastern corner of Tesson Chapel and 32 feet 6 inches to the north-north-east of the south-eastern corner of Tesson Chapel from this point extending to the said boundary stone and from the said boundary stone continuing in an this point extending to the said boundary stone and from the said boundary stone continuing in an easterly direction for a distance of approximately 458 yards to a boundary stone inscribed 'St. M. 1969 No. 6' and placed on the west side of the public road known as Rue de la Blanche Pierre near to the north-east corner of the property 'Clos de la Blanche Pierre' and from this boundary stone continuing in an easterly direction for a distance of approximately 443 yards to a boundary stone inscribed 'St. M. 1969 No. 7' and placed on the west side of the main road known as Mont Cambrai near to the of the main road known as Mont Cambrai near to the south side of the entrance to field No. 798 and from this boundary stone continuing in an easterly direction for a distance of approximately 160 yards to a boundary stone inscribed 'St. M. 1969 No. 8' and placed on the west side of the main road known. as Mont Felard near to the east hedge of field No. 799 and from the said stone continuing in an easterly direction to the middle of the said main road known as Mont Félard then continuing in a south-easterly direction along the middle of the said main road for a' distance of approximately 100 yards up to its junction with the public road known as Ruette à Pierre and then continuing in an easterly direction along the middle of the said public road Ruette à Pierre for a distance of approximately 260 yards up to its junction with the public road known as Rue de Bas and then continuing in a southerly direction along the middle of the said Rue de Bas for a distance of approximately 217 yards to a point opposite a boundary stone inscribed 'St. M. 1969 No. 9' and placed on the east side of Rue de Bas near to the west hedge of field No. 806 and from this point extending to the said boundary stone continuing from the said boundary stone in an easterly direction for a distance of approximately 100 yards to a boundary stone inscribed 'St. M. 1969 No. 10' and placed on the west side of the public road known as Le Chemin du Moulin and from this boundary stone continuing in a south-easterly direction for the said boundary stone continuing at the public road known as Le Chemin du Moulin and from this as Mont Félard then continuing in a south-easterly known as Le Chemin du Moulin and from this boundary stone continuing in a south-easterly direction for a distance of approximately 533 yards to a boundary stone inscribed 'St. M. 1969 No. 11' and placed on the west side of the public road known as La Rue de Trachy near to its junction with the private road leading to Landscape Grove and from this boundary stone extending in a straight line to the middle of the said public road and then continuing in a south-westerly and a westerly direction along the middle of the said road Rue de Trachy for a distance of approximately 183 yards up to its junction with the main road known as St. Aubin's Road and from this point continuing in a south-Road and from this point continuing in a south-easterly direction along the middle of the said main road for a distance of approximately 187 yards up to a point opposite the entrance to a private lane commonly known as Belvedere Lane which runs commonly known as Belvedere Lane which runs from the north-west corner of Belvedere Terrace to Victoria Avenue and from this point continuing in a southerly direction along the middle of the said lane up to its junction with the main road known as Victoria Avenue and from this point continuing in a southerly direction across Victoria Avenue and the public promenade up to a boundary stone inscribed 'St. M. 1969 No. 12' placed against the sea wall at a point approximately 91 yards to the east approximately of the boundary between the parish of Saint Andrew and the parish of Saint parish of Saint Andrew and the parish of Saint Lawrence."
