

2. to prohibit waiting—

- (a) in the length of road specified in Schedule 1 to this notice ;
- (b) in the lengths of road and on the sides of road specified in Schedule 2 to the notice ; and
- (c) between the hours of 8 a.m. and 6 p.m. on any day other than a Sunday on the side of road specified in Schedule 3 to this notice for a longer period than 30 minutes in any one hour.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

The restriction in (c) above does not apply to an invalid carriage; a vehicle issued to a disabled person by the Government in lieu of an invalid carriage; a vehicle left by a driver who because of severe physical disability has been issued with an exception by Carmarthenshire County Council which is displayed on the vehicle in a prominent position; or a vehicle left by a driver who has been issued with a yellow car badge under the disabled drivers' scheme and the badge is placed in a conspicuous position on that vehicle.

The Order makes permanent the prohibitions and restrictions imposed by the Trunk Roads (Various Roads, Carmarthen) (Prohibition and Restriction of Waiting) (Experimental) Order, 1968, as varied by the Trunk Roads (Various Roads, Carmarthen) (Prohibition and Restriction of Waiting) (Experimental) (Variation) Order, 1968, with one change, namely, that instead of vehicles being restricted between the hours of 8 a.m. and 6 p.m. on any day other than Sunday from waiting for a longer period than 30 minutes in any one hour on the north-west side of a specified length of Spilman Street, vehicles are now prohibited from waiting there at all times.

SCHEDULE 1

That length of the London—Fishguard Trunk Road (A.40 and A.48), at Carmarthen in the county of Carmarthen, known in part as Picton Terrace, in part as Morfa Lane, in part as Spring Gardens, in part as Coracle Way and in part as Carmarthen Bridge, which extends from a point 60 yards west of its junction with Picton Place to a point 127 yards south of its junction with Station Road, a distance of approximately 1,564 yards.

SCHEDULE 2

Lengths and sides of the Llandilo—Carmarthen Trunk Road (A.40) (hereinafter referred to as "the trunk road"), at Carmarthen in the county of Carmarthen

1. That length of the trunk road, known in part as Castle Hill, in part as Spilman Street, in part as Church Street and in part as Priory Street, which extends from its junction with that length of the London—Fishguard Trunk Road (A.40 and A.48) known as Coracle Way to a point 37 yards south-west of its junction with North Parade, a distance of approximately 601 yards.

2. The south-east side of that length of the trunk road, known as Priory Street, which extends from a point 37 yards south-west of its junction with North Parade to a point 42 yards north-east of its junction with Penuel Street, a distance of approximately 211 yards.

3. The north-west side of that length of the trunk road, known as Priory Street, which extends:

- (a) from its junction with North Parade to a point 33 yards south-west of its junction with The Avenue, a distance of approximately 20 yards ; and
- (b) from a point 5 yards south-west of its junction with The Avenue to a point 14 yards south-west of its junction with Penuel Street, a distance of approximately 68 yards.

4. That length of the trunk road, known in part as Prior Street and in part as Abbey Mead, which extends from a point 42 yards north-east of its junction with Penuel Street, in a north-easterly direction for a distance of 803 yards.

SCHEDULE 3

Sides of the Llandilo—Carmarthen Trunk Road (A.40) (hereinafter referred to as "the trunk road"), at Carmarthen in the county of Carmarthen

1. The north-west side of that length of the trunk road, known as Priory Street which extends:

- (a) from a point 37 yards south-west of its junction with North Parade to that junction ;
- (b) from a point 33 yards south-west of its junction with The Avenue to a point 5 yards south-west of that junction, a distance of 28 yards ; and
- (c) from a point 14 yards south-west of its junction with Penuel Street to a point 42 yards north-east of that junction, a distance of 56 yards.
