## WAGES COUNCILS ACT 1959

*Fur Wages Council (Great Britain)*

The Fur Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment and Productivity proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Fur) Order 1967 (Order Z.(85)) as amended by the Wages Regulation (Fur) (Amendment) Order 1968 (Order Z.(87)); (2) varying the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Fur) (Holidays) Order 1967 (Order Z.(84)); and (3) the revocation of Order Z.(85) and Z.(87).

Particulars of the proposals are contained in the Wages Council's Notice Z.(88) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 6th March 1970. Any such representation should bear the writer's address and signature and be sent to the Secretary, Fur Wages Council (Great Britain), 12 St. James's Square, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections, and quote the number of the Wages Council's Notice of Proposal Z.(88).
