*The County of York West Riding, Public Path Stopping Up (No. 6) (Kiveton Park Colliery) Order, 1969.*

Notice is hereby given that on the 23rd February 1970 the County Council of the West Riding of Yorkshire confirmed the above-named Order.

The effect of the Order as confirmed is to stop up a length of public right of way running from Stockwell Lane, Kiveton Park to the boundary between the Parishes of Wales and Harthill with Woodall in the Rural District of Kiveton Park over land required for a reclamation scheme to be carried out on land south-west of Kiveton Park Colliery.

Any such application must be in accordance with the Public Rights of Way (Applications to Quarter Sessions) Regulations 1952 (S.I. 1952 No. 559) and notice thereof must be given in writing to the Clerk of the Peace for the County of Huntingdon and Peterborough, County Buildings, Huntingdon, specifying the details laid down in the Regulations.

A copy of the Regulations and an extract from section 31 of the above Act regarding such applications are available for inspection together with the map and statement.
