TOWN AND COUNTRY PLANNING ACTS, 1962 AND 1968

Blackpool

The Minister of Transport hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping-up of a length of Back Waterloo Road, Blackpool to enable development consisting of alterations and extensions to shop premises and provision of holiday flats above with associated amenities including play area and cafe to be carried out in accordance with planning permission granted to Avenue Property and Investment Co. (Leigh) Limited.

The proposed Order will require the provision of a new highway.

During 28 days from the 10th March 1970 copies of the draft Order and relevant plan may be inspected at all reasonable hours at the Municipal Buildings, Town Hall Street, Blackpool and may be obtained free of charge from the Ministry of Transport (quoting HLL 70/140/013) at the address stated below.
