Norton Conservation Area

Beauchief Hall Conservation Area

Beauchief Abbey Conservation Area

The area comprises approximately 13.5 acres and is situated on the south side of Abbey Lane at its junction with Beauchief Abbey Lane and includes lands on both sides of that Lane and on the eastern side of Beauchief Drive.
