ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Church Street, Highbridge)
(Restriction of Waiting, Loading and Unloading) Order 1970.

Following an experimental loading and unloading restriction conducted during the 1968 and 1969 summer seasons, the Minister of Transport proposes to make an Order under section 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to:

- (a) re-enact the existing restrictions relating to the waiting of vehicles; and
- (b) prohibit loading and unloading between 8.30 a.m. and 6 p.m. on any Saturday during the period 1st June to 30th September

in that length of the Exeter-Leeds Trunk Road (A.38), known as Church Street at Highbridge, Burnham-on-Sea, Somerset, from its northern jnction with Burn-ham Road to a point 100 yards south-west of its junction with Market Street.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle except as at (b) above, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
