HIGHWAYS ACT 1959

The M62 Motorway (Lofthouse to South of Ferrybridge Side Roads) (No. 2) Order 19

The Minister of Transport hereby gives notice that he proposes in relation to the part of the M62 Motorway which will be situated between Lofthouse and Leys Lane, Knottingley in the County of York, West Riding, to make under section 13 of the above Act an Order which will—

(a) authorise the Minister—

- (i) to improve, raise, lower or otherwise alter highways,
 - (ii) to stop up highways,
 - (iii) to construct new highways (including a temporary highway) and
 - (iv) to stop up private means of access to premises,
- all on or in the vicinity of the route of the above-mentioned part of the said Motorway, and

(b) provide for the transfer of each of the said new highways to the highway authority specified therefor in the Order as from the date on which the Minister notifies that authority that the new highway has been completed and is open for through traffic.

These proposals (except in respect of the temporary highway) are in place of those provided for in the M62 Motorway (Lofthouse-South of Ferrybridge) Side Roads Order 19, notice of the proposal for which was published in so far as the same relate to Schedule No. 3 and Plan No. 3 of that Order which proposals are withdrawn.
