##### PART I

###### *Description of Site of Existing Path*

That length of Footpath No. 395 from its junction with the County Class I Road (Route A.467) at Commercial Road, Abercarn in a westerly and north-westerly direction to its junction with the bridge over the River Ebbw north of the Abercarn Welfare Ground a distance of 250 yards or thereabouts as shown marked a-b on the plan annexed to the Order.

##### PART II

###### *Description of Site of Alternative Highways*

The new highways to be provided as follows by the Developers shall be of a width and standard of construction at least equal to the section of Footpath No. 395 which they are replacing:

- (a) From the junction of Footpath No. 395 with the bridge over the River Ebbw in a north-westerly, northerly and westerly direction to join the County Class I Road (Route A.467) at Commercial Road, Abercarn a distance of 373 yards or thereabouts as shown marked e-f on the plan attached to the Order, and
- (b) From the junction of Footpath No. 395 with the bridge over the River Ebbw in a southerly and westerly direction to join the County Class I Road (Route A.467) at Commercial Road, Abercarn a distance of 360 yards or thereabouts and as shown marked c-d on the plan attached to the Order.
