TOWN AND COUNTRY PLANNING ACTS 1962 AND 1968  
*The Stopping-up of Highways [(County of Essex)  
(No. 16) (Order 1968)] (Variation) Order 1970*

Notice is hereby given that the Minister of Housing and Local Government in exercise of the powers conferred on him by sections 153 and 217 of the Town and Country Planning Act 1962 as amended by section 89 and paragraph 52 (c) of Schedule 9 of the Town and Country Planning Act 1968 and all other powers enabling him in that behalf, proposes to make an Order which will vary "The Stopping-up of highways (County of Essex) (No. 16) Order 1968" made by the Minister of Transport, by substituting a new definition for "the deposited plan", and the plan to the original Order will be substituted.

The effect of the Order will be that the footpath required to be provided by the "Stopping-up of Highways (County of Essex) (No. 16) Order 1968" between the railway and Hume Avenue at Brunel Close, Hume Estate, Tilbury, will be substituted by a new footpath between the two points.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the offices of the Thurrock Urban District Council at Whitehall Lane, Grays, Essex, between the hours of 9 a.m. and 5 p.m. Mondays to Fridays.

Any representation or objection with respect to the Order may be sent in writing to the Minister of Housing and Local Government, Whitehall, London S.W.1 (Reference P11/1725A/150/4), not later than 14th May 1970 and should state the grounds on which it is made.
