Contract cleaning is a service trade which has expanded considerably in recent years. There is virtually no established machinery for the negotiation of pay and conditions of service. The Government consider that a study should be made of the problem of low pay in this trade, including the factors responsible for low pay, the scope for raising productivity, and the circumstances of the workers concerned.

Accordingly, in pursuance of her powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State hereby refers to the National Board for Prices and Incomes for examination, with particular reference to the problem of low pay, the question of the pay and conditions of service and the principles for determining these of workers employed in the contract cleaning trade.

In paragraph 69 of the White Paper on Productivity, Prices and Incomes Policy after 1969 (Cmnd. 4237), the Government announced its intention of asking the National Board for Prices and Incomes to initiate investigations in depth into those cases where low pay is a major problem and to suggest the means by which progress can be made, case by case, industry by industry.

In September 1966, the National Board for Prices In September 1966, the National Board for Prices and Incomes was requested by the Government to examine and report on the pay and conditions of service of ancillary workers in the National Health Service and the principles for determining these. In its report in March 1967, the Board pointed out that the Service included a large concentration of the lowest paid workers in the country and made certain proposals for raising their productivity and their pay.

The Government consider that it would be desirable for a study to be made of the progress that has been made in implementing these proposals and of any difficulties that have been encountered. The study should include the factors responsible for low pay, the scope for raising productivity, and the circumstances of the workers concerned.
