Richmond Terrace and New Scotland Yard Site, Whitehall, Public Local Inquiry

On the direction of the Secretary of State for Local Government and Regional Planning, a public local inquiry will be held into proposals by the Minister of Public Building and Works for the redevelopment of the above site, which is more particularly described in the Schedule hereto. The terms of reference of the Inspector conducting the inquiry are as follows:

"Accepting the objectives of the Martin plan for Whitehall, to hear and report upon objections to the redevelopment proposals for the Richmond Terrace/New Scotland Yard site, with particular reference to the proposed demolition of Richmond Terrace and the former headquarters of the Mertopolitan Police."

The inquiry will be held by Mr. Harold Willis, Q.C. and will open at The Assembly Hall, Church House, Westminster at 10.30 a.m. on Monday, 13th July 1970. A copy of an explanatory Memorandum on the Minister of Public Building and Works' proposals, together with plans of the proposed redevelopment and a certified copy of that part of the Initial Development Plan for Greater London relating to the area of the City of Westminster have been deposited for public inspection in the Record Room (B.21), Main Building, County Hall, S.E.1. A further copy of the Memorandum and plans, together with a certified copy of that part of the Initial Development Plan relating to the area of the City of Westminster have been deposited in Room 18.23 at Westminster City Hall, Victoria Street, S.W.1. The copies so deposited are available for inspection free of charge by all persons interested at the places mentioned above during the usual office hours. Copies of the Memorandum can also be obtained free of charge from Room 8/4, Ministry of Public Building and Works, Elizabeth House, 39 York Road, S.E.1.

The Martin and Buchanan Reports on Whitehall are published by Her Majesty's Stationery Office, price £2 10s. 0d. under the title Whitehall: a plan for the national and government centre, accompanied by a report on traffic. Copies are also available for inspection at County Hall and Westminster City Hall under the arrangements described above.

Any person who wishes to make representations should notify the Secretary to the Whitehall Inquiry, Room 703, Queen Anne's Mansions, Queen Anne's Gate, S.W.1, not later than 19th June 1970 and should state the nature of the representations that he wishes to make. Any person who has made representations may appear at the inquiry on his own behalf or be represented by Counsel, Solicitor, or any other person. The Secretary of State does not however consider that parties need necessarily incur the cost of legal representation in order to present their case.
