*Town and Country Planning Acts 1962 and 1968*

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the Town and Country Planning Act 1962 to authorise the stopping up of two lengths of highway and three footpaths at Croespenmaen, Crumlin, Monmouthshire, to enable industrial development to be carried out in accordance with planning permission granted by Monmouthshire County Council under Part III of the said Act.

The proposed Order will require the provision of a new highway maintainable at the public expense, for which the highway authority is to be the Abercarn Urban District Council.
