The Trunk Roads (50 m.p.h. Speed Limit) (No. 1) (Wales) Order 1970

Lengths of the London—Holyhead Trunk Road (A.5) (hereinafter referred to as "the trunk road"), in the County of Anglesey.

1. That length of the trunk road which extends from a point 14 yards east of its junction at Bryngwran with the road to Tre-Hwfa to a point 107 yards west of its junction at Gwalchmai with the road to Gwalchmai Uchaf, a distance of approximately 2 miles.

2. That length of the trunk road at Gwalchmai, which extends from a point 70 yards east of its junction with the road to St. Morhaiarn's Church to a point 704 yards east of its junction with the road to Capel Belan, a distance of approximately 1 mile.
