The Trunk Road (High Street, Bala) (Prohibition and Restriction of Waiting) Order 1970

The prohibition in (b) above does not apply to an invalid carriage; a vehicle issued to a disabled person by the Government in lieu of an invalid carriage; a vehicle left by a driver who because of severe physical disability has been issued by the County Council with an exemption which is displayed on the vehicle in a prominent position; or a vehicle left by a driver who has been issued under the disabled drivers' scheme with a vellow hadre which is placed drivers' scheme with a yellow badge which is placed in a conspicuous position on the vehicle.
