

ROAD TRAFFIC ACTS

ROYAL COUNTY OF BERKSHIRE

Royal County of Berkshire (Various Minor Roads) (Weight Restriction) Order, 1970

Notice is hereby given that the Berkshire County Council have made an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by the Transport Act, 1968, the effect of which is to prohibit any vehicle the weight of which whether laden or unladen exceeds 2 tons from proceeding in any of the lengths of road specified in the Schedule to this notice.

The alternative routes for heavy traffic are:

1. Church Lane, Shinfield, via Brookers Hill and A.327 and vice versa.
2. Bostock Lane, Englefield, via A.4, A.340 and Common Hill Road, and vice versa.

Exceptions are included in the Order to enable the vehicle to be used for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the length of road, to be used for agricultural purposes in connection with land adjacent to the length of road or for the conveyance or haulage of timber felled upon that land, to enable the vehicle if it cannot be used conveniently for such purpose in any other road to be used in connection with any building operation or demolition the removal of any obstruction to traffic the maintenance of the road or the services therein.

Copies of the Order and relevant map may be inspected at the Office of the County Surveyor, First Floor, Kennet House, Kings Road, Reading, between the hours of 9 a.m. and 5 p.m., Mondays to Fridays inclusive.

The Order will come into force on 19th July 1970. If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 16th July 1970, apply to the High Court for this purpose.

SCHEDULE

In the Parish of Shinfield

1. Church Lane between its junction with Hollow Lane (A.327) and its junction at the Six Bells Public House with the road leading from the road A.33 to Brookers Hill.

In the Parish of Englefield and Sulhamstead

2. Bostock Lane, Englefield, between its junction with the A.4 and its junction with Common Hill Road. (374)

ROYAL COUNTY OF BERKSHIRE

Royal County of Berkshire (Blacknest Gate Road, Sunninghill) (Prohibition of Waiting) Order 1970

Notice is hereby given that the Berkshire County Council have made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to revoke the Royal County of Berkshire (Sunninghill, Blacknest Gate Road) (No Waiting) Order 1967, and to prohibit any person from causing or permitting a vehicle to wait at any time on Saturdays, Sundays, Bank Holidays and Good Friday on the length of road specified in the Schedule to this notice.

Exceptions are included in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, to enable the vehicle if it cannot be used conveniently for such purpose in any other road to be used in connection with a wedding, funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, or to enable a vehicle to take in petrol, water, oil or air from any garage situated on or adjacent to the said length of road.

Copies of the Order, and relevant map, may be inspected at the office of the County Surveyor, First Floor, Kennet House, King's Road, Reading, between

the hours of 9 a.m. and 5 p.m. on Mondays to Fridays inclusive.

The Order will come into force on 18th July 1970.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 16th July 1970, apply to High Court for this purpose.

- (A) *(Charminster Road) (Prohibition and Restriction of Waiting) Order, 1970*
- (B) *(Maxwell Road) (Restriction of Waiting) Order, 1970*
- (C) *(Hankinson Road) (Restriction of Waiting) Order, 1970*

Notice is hereby given that the Bournemouth County Borough Council propose to make Orders under section 1 (1), (2) and (3) and section 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

- (a) The effect of the Order relating to Charminster Road will be to consolidate all the existing traffic orders prohibiting or restricting vehicles waiting thereon into one order and, in addition, restrict vehicles from waiting between the hours of 8 a.m. and 7 p.m. on the western side of Charminster Road from its junction with Maxwell Road to its junction with Hankinson Road.
- (b) The effect of the Orders relating to Maxwell and Hankinson Roads will be to restrict vehicles from waiting on certain parts of these roads between 8 a.m. and 7 p.m.

Exceptions will permit waiting for the purposes of:

- (a) picking up and setting down passengers,
(b) loading or unloading goods

and, where necessary, in connection with:

- (c) the maintenance of the roads, and
(d) the supply of gas, electricity and water.
