### Y SWYDDFA GYMREIG

#### *The Trunk Road (Sardis) (Temporary Prohibition of Traffic) Order 1970*

Notice is hereby given that to enable works to be carried out the Secretary of State has made an Order under section 12 (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is that no person shall cause any vehicle to proceed in that length of the Swansea—Manchester Trunk Road (A.483), at Sardis in the County of Carmarthen which extends from a point 183 yards south of Sardis Baptist Chapel in a southerly direction for a distance of 60 yards. The Order will come into operation on the 18th July 1970 and will remain in force until the works have been completed.

Traffic will not be affected by the closure as a diversion route has been constructed alongside the length of the A.483 specified above.

#### *The Trunk Road (Various Roads, Llanidloes) (Prohibition of Waiting) Order 1970*

Notice is hereby given that the Secretary of State has made an Order under section 1 of the Road Traffic Regulation Act 1967, the effect of which is to revoke and re-enact with modifications the Trunk Road (Various Roads, Llanidloes) (Prohibition of Waiting) Order 1968 and to prohibit waiting at any time on any of the sides of the road specified in the Schedule below.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

with in relation to the Order, you may, within six weeks from the 9th July 1970, apply to the High Court for this purpose.

### SCHEDULE

*Sides of the Newtown—Aberystwyth Trunk Road (A.492) (hereinafter referred to as "The Trunk Road"), at Llanidloes in the County of Montgomery.*

- The north-west side of that length of the trunk road, known as Long Bridge Street, which extends:
  - from its junction with Brook Street to a point 50 yards south-west of that junction;
  - from a point 13 yards north-east of its junction with Church Lane to a point 13 yards south-west of that junction; and
  - from its junction with Short Bridge Street to a point 18 yards north-east of that junction.
- The north-west side of that length of the trunk road, known as China Street, which extends from its junction with Short Bridge Street to a point 95 yards south-west of that junction.
- The south-east side of that length of the trunk road, known as Long Bridge Street, which extends:
  - from its junction with Brook Street to a point 95 yards south-west of that junction; and
