### ROAD TRAFFIC REGULATION ACT 1967

Notice is hereby given that the Minister of Transport in exercise of his powers under section 74 (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 proposes to make an Order the effect of which will be that no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the Schedule to this notice.

The draft Order which together with a map showing the length of the road concerned and a statement of the Minister's reasons for proposing to make the Order may be examined at:

#### SCHEDULE

That length of the London—Norwich Trunk Road (A.11) in Essex from a point 365 yards south of its junction with Potter Street (old A.11) at Epping to the north side of its junction with A.122 at Harlow a distance of 3 miles 330 yards.

### ROAD TRAFFIC REGULATION ACT 1967

*The Trunk Road (Midland Road, Nuneaton) (Prohibition and Restriction of Waiting) Order, 1970*

The Minister of Transport proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall cause or permit any vehicle to wait:

- in that length or on that side of road specified in Schedule 1 to this notice; and
- between the hours of 8 a.m. and 8 p.m. on any day on the side of road specified in Schedule 2 to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

A copy of the Order, together with a plan illustrating the proposal, may be inspected during all reasonable hours at the offices of Nuneaton Borough Council at the Council House, Nuneaton.
